MEMBER ADVOCATES TRANSFORM *HELP* INTO *HOPE*


I bet each of us can think of a person who helped shape our lives with encouragement and advice, their ability to see, and help us reach, our fullest potential. For our members, these guides are our Member Advocates, staff and volunteers, who invest their time and expertise to helping others set and reach their goals, as well as navigate the challenges of daily life. Our choice to describe the essential nature and activities of this role as Member Advocacy is a deliberate one. Advocacy empowers and encourages, holding us up when we don't feel strong, and helping us develop self-determination as we grow in confidence.



Member Advocacy begins with a warm welcome to Trinity Center followed by a conversation to gather information and establish a sense of the person's experiences, strengths, and challenges. Member Advocates work with Members to establish written, individualized Action Plans to set goals--usually around housing, health, education and income--coupled with action steps and resources to achieve each benchmark. On a day-to-day basis, Members can touch base with Advocates for quick support and information, or schedule longer appointments to review their own progress, challenges and next steps.

At Trinity Center, we meet people's immediate needs, and guide each other to reach our fullest potential and self-reliance. You are an important part of the community of support we create. Thank you for helping us achieve so much over the years, and look with confidence toward our dreams for the future.


